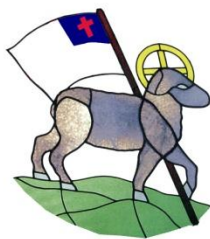

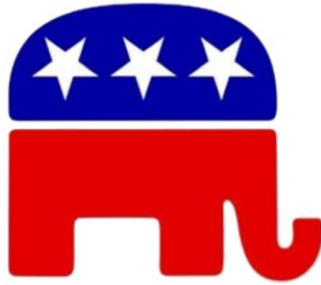

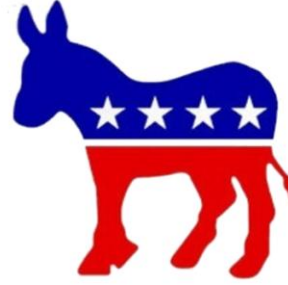

Reducing Transgender Imbalance Act

Transgender imbalance is a terrible condition where an individual develops an imbalance between their perceived gender and their biological body. The outbreak of transgender imbalance in countries influenced by American culture has created a detrimental effect on women's sports. This detrimental effect is that there are now "female athletes" who show up to sports competitions in male or transgender bodies instead of female bodies.

A transgender body is a body that doesn't exist naturally in nature. Biological transgender bodies are created when an individual develops a case of transgender imbalance that is so severe the individual has their male or female body medically modified into a "transgender body" that is somewhere between male and female.

When it comes to dealing with athletes who develop this condition, there is an obvious choice Americans face. This choice is:

- Agree with moral codes and politicians who want to discourage athletes from developing transgender imbalance by making it legal to have a rule in any rulebook that

would disqualify a "female athlete" for showing up to a competition in either a male or transgender body instead of a female body.

- Disagree with the above moral codes and politicians.

The choice is between being for or against allowing sports organizations to define a "female athlete." Defining a woman is difficult, but all that is needed to define a "female athlete" are a few rules concerning acceptable body types. The Reducing Transgender Imbalance Act creates a nationwide default that rulebooks of the organization arranging the event will define a "female athlete." However, each State will retain the right to override this default and define a "female athlete" within that State's borders.

The first draft of the Reducing Transgender Imbalance Act dealt only with biological transgender bodies. The finished product also deals with a different type of transgender body. If intelligent machine humans aren't here already in a research laboratory somewhere, they will be here soon.

Their mechanical "transgender bodies" have something in common with biological transgender bodies. What both body types have in common is that they don't exist naturally in nature. Biological transgender bodies don't exist naturally in nature since they are created by taking a male or female body that does exist naturally in nature and modifying that body into a body that doesn't exist naturally in nature. Since mechanical transgender bodies will be manufactured from raw materials using methods designed by engineers and scientists they don't exist naturally in nature. Because it was so easy to accomplish, the law works for biological and mechanical transgender bodies.

The "Reducing Transgender Imbalance Act" is a federal law that will address the problem in States where there are currently no laws. If a State doesn't agree with the solution the law creates, that State can pass a State law that overrides the solution in the Reducing Transgender Imbalance Act within the borders of that State. The law's solution is that the government will stay out of the business of writing rules for organizations that arrange sports competitions except for sports competitions run by the government, such as sports in public schools.

Passing the law will make it clear that rules of competition can disqualify "female" athletes who show up for competition in male or transgender bodies or let them compete. The law creates legal clarity so organizations that arrange sports competitions can include common-sense rules in their rulebooks or include rules that defy common sense.

The law doesn't violate the Constitution since it contains what can be called a nullification clause. The nullification clause clarifies that any State can pass a State law overriding the Reducing Transgender Imbalance Act within that State's borders. For example, States can pass laws that force organizations that arrange sports competitions to allow "female" athletes who show up for one of their competitions in a male or transgender body to be allowed to compete. If a State doesn't nullify the law, it means the State agrees it is a law that they want to follow.

The name for this law originates from the fact that just introducing it will force a conversation about transgender bodies and transgender imbalance. This conversation will lead some individuals to be cured of transgender imbalance. How many will be cured is unknown. However, if just one person is cured, the law has lived up to its name.

The suggested wording for the law is as follows:

The law's purpose is to create guidance for organizations involved in arranging sports competitions when no State laws are available to clarify what rules pertaining to athletes in transgender bodies will be legal or against the law.

WHEREAS, transgender bodies are bodies that don't exist naturally in nature, a definition for a transgender body can easily be created; and,

WHEREAS, the technology to create humans in biological transgender bodies already exists; and,

WHEREAS, the technology to create humans in mechanical transgender bodies will soon exist if it doesn't already; and,

WHEREAS, the technology to create both biological and mechanical bodies that don't exist naturally in nature has created a problem for organizations that arrange sports competitions for athletes in bodies that do exist naturally in nature; and,

WHEREAS, the American Constitution doesn't prevent the federal government from passing a law that becomes a solution to a problem as long as that federal law is clear that a State government can write laws to create a different solution within the borders of that State:

NOW, THEREFORE, a transgender body is defined as any human body that does not exist naturally in nature due to being manufactured from raw materials (mechanical transgender bodies) or due to a biological body being physically modified; and,

THEREFORE, organizations that arrange sports competitions are allowed to set their own rules concerning when athletes in transgender bodies, athletes in male bodies and athletes in female bodies can be disqualified from competitions they arrange except when in the jurisdiction of States that have laws that don't allow these organizations to set their own rules concerning when athletes in transgender bodies, athletes in male bodies and athletes in female bodies can be disqualified from competitions they arrange.

Notice that there is no detailed description describing when a male or female body technically becomes a "transgender body." The exact moment a male or female body becomes a transgender body doesn't need to be known to write a common sense rule that disqualifies a "female" athlete for showing up for a competition in either a male or transgender body. If a "female" athlete was born male, scientific tests will always disqualify the athlete for breaking the rule that "she" can't be in a male or transgender body even if science can't conclusive prove "her" male body has become a transgender body. The law also applies to "male" athletes who show up for a competition in a female or transgender body.

Transgender bodies can also be created by medical procedures to treat physical illnesses or by intentionally using performance-enhancing drugs. If an organization wants to disqualify these bodies because the organization feels the treatments create an advantage, that will still be legal. Most professional sports already have rules to disqualify these athletes.

There are transgender bodies that do exist naturally in nature due to rare birth defects that create bodies that are naturally somewhere between male and female. These bodies don't meet the legal definition of a transgender body as created by the law since they exist naturally. The law doesn't address these bodies as whatever problems they cause have already been addressed.

The law does not override any current laws dealing with race or sexual preferences for humans in male, female or transgender bodies.

To some, it may seem just plain crazy that this law does need to be proposed.

What is even crazier is that it does need to be passed.
